# 2009 OARA Employee Scholarship Program

Applications can be made online for post-secondary scholarships for the children of OARA Direct Member employees at http://oara.com/foundation.php. Last year we handed out three \$1,000 scholarships to very worthy candidates. The deadline for applications is March 31, 2009.

# Used Tire Stewardship Plan

A draft plan has been posted on the Ontario Tire Stewardship website (http://www.ontariotirestewardship.org/PROGRAM.html) to manage used tires in the province - potentially bringing the last and largest province up to par with other areas. The draft plan, which is undergoing its second public revision, is to be submitted to the Minister of Environment by the end of February for approval. The plan would see manufacturers and first importers pay in to a fund that would have Collectors be paid 60c per tire plus free removal by licenced Haulers (for minimum loads of 70 tires). Auto recyclers would be encouraged to register as Collectors and would need to store tires in compliance with the Fire Code OARA has supplied comments supporting the plan and encouraging a speedy introduction. Further industry and public consultations are planned, but we remain hopeful that a program will finally be introduced in Ontario.

## Cardinal Couriers/Lynx Rate Increase

Effective January 19, 2009, OARA Member rates with Cardinal/Lynx will increase 0.75%. The revised rate card is posted in the Member Only section of our website. The Transportation Committee is scheduled to meet with Cardinal for its regular quarterly meeting on January 28, 2009 at 1:00 pm in Mississauga should any Member want to attend. If you have any input for the Committee or have any questions, please let myself or the Committee Chair (Don Fraser from AADCO) know in advance.

### **RM Recovery Core Buyer**

It has been reported by a Member that RM Recovery, a core/converter buyer out of the Brantford/Paris area may no longer be in active business. These are uncertain times in the specialty scrap business and, as always, Members are strongly encouraged to know their suppliers and feel confident that they are working with a viable and legitimate

#### Switch Out Letters and New Poster Resource

Late in 2008, the Switch Out Program mailed a new educational resource - laminated posters to help identify switches, and to highlight what NOT to put in the Switch Out bucket. Several Members have reported that the cover letter indicated that they have not been submitting switches, when in fact they have. This was a mix up on the Clean Air Foundation's behalf, that has since been corrected - the letters were inadvertently switched between those who have submitted and those who have not. CAF apologies for this error and any confusion that may have arisen.

## Car Heaven Update

The Car Heaven website is temporarily down as the references to the GM incentive are removed. The site has been pledged to be up and running early next week. In the meantime we are still capable of processing donations, both for charities and for the \$300 cash incentive on a manual basis. The Car Heaven program will continue to live beyond the new national program, mainly working with our charitable partners, but we are also investigating other incentives and promotions.

# National Vehicle Scrappage Program Update

The new national program was scheduled to be up and running for January 5, 2009. Final program adjustments and relationships are still in progress, and the Clean Air Foundation is waiting for Environment Canada to schedule a launch day. This massive program has been quite a challenge to put in place (although Ontario has been ready and waiting) and once in place will generate a significant flow of vehicles AND positive industry coverage and awareness. Stay tuned.

#### March Convention News

When Ron learned how much people paid for parts off his junked cars, he entered the auto salvage business. When he needed to grow, Ron did his first oversubscribed private stock offering. In 1999, Ford/GreenLeaf bought Ron's 140-employee Texas salvage operation - AAA Small Car World. Ron was also a founding URG Partner and Co-Founder of Actual Systems of America, the developer of the Pinnacle computer system.

In 2001, Ron founded a salvage auction in Texas. A second oversubscribed stock offering funded the venture. Ron sold to Copart a year later. Drawing on his experiences, Ron wrote How to Salvage Millions from Your Small Business. In 2003, Ron and two partners purchased Ford's salvage division. GreenLeaf had 26 locations in 15 states. Ron was in charge of legal, environmental, licenses insurance and permits. As a board member, Ron led efforts to grow sales, sharpen marketing, and lower costs in purchasing. After a turnaround, Ron and his partners sold. Ron published Green Weenies and Due Diligence, an insider's guide to the lexicon of the boardroom. A follow up to How to Salvage Millions from Your Small Business is planned for March 2009, and all registered delegates at the event will receive a copy.

Ron manages his real estate holdings, and consults and speaks on topics related to auto salvage and entrepreneurship.

We have retained the services of KCI Management to help implement a comprehensive marketing and event planning approach to this years event. Our Associate Members, Sponsors and interested Exhibitors will be seeing the sign up materials for the exhibit hall early next week. This information will also be uploaded to our website for any Direct Member that is interested.

Retire Your Ride National Vehicle Recycling Program Gets Set to Launch Retire Your Ride, the new national scrappage program, is inching towards its public launch. The Environment Minister publicly announced the program late in January, albeit with only 1/10th of the details, but that has allowed a flurry of work to finalize the program. We expect the official introduction by the Clean Air Foundation (CAF) to take place some time later this month or in early March. The Recycler Sign Up Sheet was sent to all OARA Members and ARC Members across Canada today. The program will operate very similar to Car Heaven, but will be supported by a larger advertising and media campaign, and a wider variety of incentives. For the launch, the \$300 cash incentive will provide the core incentive. We are not sure of the other incentives at this time or whether dealerships or an auto manufacturer will be involved

Please take the time to review the sign up sheet, sign and return the form to the CAF - I would imagine everyone on Car Heaven or the Tacoma program would be interested. There are no costs to join, but there are future steps to take (signing an agreement with the CAF, participating in training to the Code of Practice, and passing at least one audit to the Code during the program). Vehicles are going to be valued at \$55 for Recyclers in Ontario and this will remain an important funding source for OARA. We are also working on a marketing plan to obtain the best possible media coverage for participants and for the industry.

Until RYR is launched to the public. Car Heaven still has access to the \$300 cash incentive and the charity donation side. After the launch. Car Heaven will remain a solid charity vehicle donation program

# Cardinal Couriers/Lynx Cubing Policy

Effective March 1, 2009, OARA Members shipping with either Cardinal or Lynx will NOT be subject to their cubing policies. As you may know, cubing is the policy of re-pricing shipments based on the cubic volume of a package rather than the actual weight. For bulky but light packages, this reduces a shippers revenues as a vehicle is filled by volume before it is filled by weight. With the move to best practice shipping to properly protect a product, more parts were being re-priced at a higher amount because of cubing. This decision by Cardinal/Lynx will allow more Members to adopt effective packaging without paying for it through higher rates.

This change was brought about through consultation with OARA Transportation Committee, headed by Don Fraser. We applaud the efforts of the Committee and Cardinal/Lvnx for being a responsive logistics partner for OARA and its Members

Lynx have also added some categories of flat rate shipments that have been captured on a revised Member Price List republished to the Member Only section of the OARA website (in the Programs section).

#### MVDA Regulation Delayed

The Ministry of Small Business and Consumer Services has announced that implementation of the new Motor Vehicle Dealers Act. 2002 (MVDA 2002) has been delayed until January 2010. The new Act was originally expected to launch April 1, 2009. The extended implementation period comes in response to concerns expressed by industry.

# 2009 OARA Convention Summary

First, the overall details: 310 delegates representing 160 companies, 37 exhibitors in 40 booths, 39 speakers in 20 sessions, \$25,000+ in food and beverages (that we paid for), 12 Sponsors (see list below). And to paraphrase the credit card commercial: information, opportunities and contacts - priceless and incalculable.

The event kicked off Thursday with a Board dinner and meeting - every Member should thank the OARA Board for the tremendous time commitment they put in to this association, not only leading up to and at the event, but all year long.

Friday morning it was standing room only for Ron Sturgeon's first Keynote presentation on the big trends affecting our industry. Ron provoked the crowd to think about their place in this ever changing industry and not to rest for a moment, as your competitors within and outside the industry are constantly evolving. Ron has enough information in his head to write a few books - wait, he has written a few books, and attendees received a copy of Salvaging More Millions in their boodle bags from Hollander. For Members who did not attend, we have a few extra copies which we will be giving away to those who submit their completed Convention survey.

Cara Sweeny provided an overview of the Clean Air Foundation's Retire Your Ride program and the opportunities that exist for recyclers. This program has the potential to be larger than Car Heaven AND support our regulatory, educational and public engagement strategies. OARA, as the Ontario Call Centre, and ARC as the national voice of the industry, are very actively involved in crafting a program that works for recyclers.

Triple M provided a bleak review of the scrap markets (hopefully not a surprise for Members) and an uncertain forecast. This was an important step though for auto recyclers to interact with the scrap industry, both on an association and business level, and we have invited them back next year.

Warren Barnard from the UCDA talked about the upcoming new regulations under the Motor Vehicle Dealers Act. Disclosure of all kinds damage to a vehicle will become much more important.

Finally, Glenda Gies from the WDO provided an overview of the soon to be launched Used Tire Stewardship Program. Once in place, auto recyclers can register as Collectors to receive free tire pickup plus 88c per passenger tire as a collector fee. The realistic target date is January 1, 2010, but we are still looking for ministerial approval and many more implementation details. Good news indeed.

The Trade Show kicked off to a full house. I can't thank our Exhibitors enough for the little extras they all had to build traffic and generate some excitement. Special thanks to Wholesale Auto Parts Warehouses for the tunes and videos, and SL Marketing for their, aheem, special booth guests. Both had well attended after hours parties to boot. Everyone seemed to ratchet things up a notch and the professionalism was evident. The Trade Show has morphed from an add on to the social reception to become a major part of the overall Convention. The complete sellout certainly has helped.

Ron Sturgeon brought us back to the seminar room (with more chairs and room this time) with his newest seminar on strategic planning for auto recyclers. Again, enough information for a few books, and then some

Our Health & Safety panel ran a little over (too much information - too little time?) but there was plenty to talk afterwards and follow up in the Trade Show and Direct Meeting. Thanks to Lisa Sticca and OSSA for pulling all this information together

Scott Westbrook APU provided an overview of a "real steel" product that is coming to Canada that will help get real-world recycler information in to repairers hands earlier in the estimating process

The day wrapped up with a very entertaining Repairer-Recycler-Insurer Roundtable, moderated by Darryl Simmons from Collision Repair and Canadian Recycler magazines. The panel featured Keith Hudd from Economical, Gary McKnight from Cooperators, Dominic Maurini formerly with ING, Tony Canade from Assured Auto, Sam Piercy from Budds Collision, David Gold from Standard, Dom Vetere from Dom's and Don Fraser from AADCO. Anytime these three sectors can get in the same room and talk towards common goals, it is a good thing for our industry. OARA's Green Parts initiative and resources seemed to be the highlight of the meeting, and Darryl was masterful at crafting an action plan to keep the group together and working after the event is over. OARA has created a new Committee chaired by David Gold to work with insurers and repairers to adopt the Green Parts communication strategy and expand our influence. Great work and a great result.

The Gerdau Ameristeel Recycling Reception continued among the trade show booths. It was crowded, there was lots of food, and many exhibitors reported outstanding traffic, business and opportunities. The Passport contest seemed to be a big success, getting people moving throughout and talking. Plenty of draws and contests kept things very busy all night.

On Saturday morning a significant group heard about and saw some of the changes coming to eSMP in Ontario with Phauto Pak.

The Direct Member Meeting was the largest we have every had, with 54 Directs signing in. The auditor reported that OARA remains on very sound financial footing, showing a very small surplus for 2008. The audited statements are available to any Direct Member that wants to review them in the Hamilton Office.

Elections were held and the new Board Members are Don Fraser from AADCO Auto Parts and Bob Vanleeuwen from Fergus Auto Recyclers. Lisa Sticca from Thunder Bay

Auto Parts was elected as a returning Board Member. Chairman Wally Dingman thanked outgoing Board Members Barb Sembay from North Queen Auto Parts and Dean Hellyer from Dave's Truck & Auto Parts for their years of service on the Board, and provided a commemorative plaque and Keg dinner vouchers.

Committee reports were heard from Membership (Trevor Generoux), Scholarship (Mary Poirier), Health & Safety (Lisa Sticca), Transportation (Don Fraser) and Government Affairs (Wally Dingman). Tyler Fleming and Will Steward from Navigator also supplied information to round out Wally's Government Affairs report, summarizing OARA's extensive government affairs activities. Krista Friessen provided updates on Retire Your Ride, Car Heaven and Switch Out. I provided reports on Marketing, Tacoma Recovery, Retire Your Ride and the Code of Practice, O-CAR renewals and internal communication opportunities (ie, the 2009 Member Roster, and the Member Updates).

The Employee Meeting was well attended and heard from Cardinal Couriers, Car-part.com and Hollander. We will be looking to expand and diversify the educational opportunities for employees for upcoming events.

At the Luncheon we heard from Linda Pitman, ARA President, and Michael Wilson, ARA Executive Vice President. ARA remains an active, vibrant association that is establishing great grassroots connections to affiliates such as OARA and ARC. Their Convention in Lexington KY this October is roughly 3X the size of the OARA event (but we are gaining on them) and is a great value. We will be sending out more information on special pricing to join ARA and the Convention. Jeff Sack from Sullivan Salvage won the complimentary pass to the ARA Convention at the end of the Luncheon.

During the Luncheon the new OARA Board met and elected Wally Dingman from Caughill Auto Wreckers to another term as Board Chair; Mary Poirier from Valley Automotive as Treasurer; and Lisa Sticca from Thunder Bay Auto Parts as Secretary. Committee Chairs were also ratified. A monthly conference call agenda was established, plus a strategic planning retreat for May (nothing fancy - its in Hamilton) for the Board to plan, plot and strategize.

John Couper from Couper Marketing, OARA's communication consultant, kicked off the afternoon with an overview of our Green Parts strategy and execution. The vast majority (and more) of John's content is now in the Member Only section of the website under Marketing Resources.

Michael Hoeher from H&H International Distributing, provided a case study and research on various SEDA drainage equipment installations.

Car-Part.com and Hollander both provided quick summaries of some of their eCommerce initiatives and resources.

The Convention wrapped up with a unique presentation from JustParts.com, showing their creativity and innovation that is built in to their company and product. It is always tough to the last presentation after a long two days of information overload, but their presentation held everyone. How did they do that presentation? # **Ontario Approves Tire Recycling Program**

Ontario has a new, industry-funded program to deal with the more than 12 million used tires generated each year. The program, to be delivered by Ontario Tire Stewardship beginning this fall, will:

-- See 91 per cent of used car and truck tires recycled into higher end uses in year one;

- -- Clean up the nearly three million used tires stockpiled across the province;
- -- Include the recycling of large industrial and off-road tires, which are currently not collected or recycled;
- -- Include funding for public education programs and research into greener ways to recycle tires;

--- Registered Collectors, including Auto Recyclers will receive complimentary pickup and an 88¢ per passenger tire collection fee as part of the program. Ontario's program is the first of its kind in Canada as it is based on Extended Producer Responsibility, a cornerstone of all of Ontario's recycling programs, which include the Blue Box, household hazardous waste and waste electronics programs. Manufacturers, brand owners and importers will pay an estimated \$74 million in the first year to run the program. They will pay Ontario Tire Stewardship a fee based on each tire they put into the market. The fee is currently set at \$5.84 for a passenger vehicle tire, with no portion going to the government.

Our positioning has been to talk with the experts (us) to quickly design and deploy a solution that works for everyone - manufacturers, dealers (new and used), auto recyclers and ultimately consumers. Until then, the \$300 incentive has been generating good results (500 vehicles in the past week, based on some great exposure for the program on CTV/Canada AM) and the Clean Air Foundation is working on other modest incentives to reach out to the media again and again.

The Used Tire Stewardship Program development continues. Don Fraser from AADCO Auto Parts is the OARA rep on the Technical Advisory Committee. They are meeting every two weeks to be ready for a September 1st introduction. The initial documents and registration forms all continue to look positive for us. We expect that they will be ready for Members to sign up as Collectors by the end of this month. We are trying to document the condition that "all Used Tires are stored in accordance with all requirements made from time to time by the Ontario Ministry of the Environment and the Ontario Office of the Fire Marshal; and that the Collector will store all Used Tires in a manner that ensures they are free of foreign material and excessive moisture, secure, and accessible for efficient pickup." This will be key to getting the complimentary pickup and 88¢ subsidy.

Please ensure that you are paying for all Car Heaven, Retire Your Ride and Tacoma vehicles. Your payment triggers the ability to write a tax receipt, issue the \$300 incentive or receive further vehicles. Issuing statements, following up on donor questions and complaints slows the Office down and reduces our productivity.

One of the benefits of your OARA membership is the information you receive. Please ensure you think carefully when you distribute or forward our information - especially our Updates. We have numerous cases of non-members or sometimes Associate Members having copies of our internal correspondence. As we move deeper in to our government affairs activities, develop programs and source more vehicles, it is critical that we collectively retain control.

Speaking of more vehicles, we are in final negotiations with another vehicle manufacturer to run a program similar to the Toyota Tacoma program. Stay tune for more details,

We are also in negotiations with other suppliers that could be deemed to be in competition with existing suppliers or Associates. It is important to keep this information under wraps as long as possible.

We have had a number of very successful meetings with politicians and their key staff, all the way up to the Premier's Office. Our lobbyist, Navigator, is finalizing a grassroots MPP lobbying program to take our efforts to the next level. The over-riding goal is the implementation of an effective licencing or accreditation scheme in Ontario for all ELVs - scrap cars and Irreparables alike. I hope everyone has taken some steps to nurture a relationship with their MPP.

Similarly, we are about to unfurl a media and marketing campaign for Members to help implement and push at the grassroots level. Any effort that you have put in to get to know your local media and getting them to know about you, will make this program more successful for OARA and your business.

The Clean Air Foundation has launched a Switch Out contest with Collision Repair Magazine - keep pulling and submitting and make sure an OARA Member wins the Grand Prize.

The 75th Edition Hollander Wheel/Wheel Cover binders have been ordered and we should receive them next week for re-distribution.

The OARA Transportation Committee has a meeting next week at the Cardinal Offices - if you have any input, questions or concerns, please let anyone on the Committee know.

Year to date vehicles received though the OARA Call Centre:

Car Heaven = 1,116 Retire Your Ride = 2,900 Tacomas = 627 nationally, with 165 in Ontario

There are presently 92 participants on RYR in Ontario, by far the largest group, and all are OARA Members. And we are processing about 2/3rds of the vehicles. At least 8 non-members have tried to join RYR in Ontario, but CAF has agreed that OARA can implement some pre-screening for issues such as licencing and zoning, much like our O-CAR criteria.

# Tire Stewardship

Still no registration documents or process in place to register as Collectors, but we have a third Technical Committee meeting on the 15th where we hope to learn more. So nobody has missed anything. The Program still seems viable for its September 1st start date.

#### **RYR Incentive Changes Coming?**

With the USA passing their Cash For Clunkers program, Ottawa is being pressured to take a harder look at their vehicle retirement efforts (note the language differences in Canada and the USA - here we call it vehicle retirement or recycling; there they call it scrappage or clunkers. The US model has little room for professional auto recyclers and no room to help the industry, where RYR takes some steps to promote and support the industry. The US program might dispose of their vehicles at public auctions or directly to scrap dealers - gaspl). The dealers and unnecessarily add to our national debt. ARC is lobbying for a larger incentive (\$1,500) through RYR for newer cars (2005 and newer) available for a wider range of vehicles (1998 and older) and compensation for participating recyclers. These are just concepts at this time and there is no guarantee that anything is going to change. The Clean Air Foundation is working on other interesting incentive partners that could also give the program and boost.

# Bottom Up Budgeting by Ron Sturgeon

I was proud to learn about bottom up budgeting in my stint at Ford Motor Co. after I sold them my recycling facilities in 1999. It's easy to just work on a budget, forecast some growth in sales or products, make the expenses fixed or variable relative to the sales, and then charge off to accomplish the goal. There's the rub, hitting the goal. Without bottom up budgeting and a bridge plan (another term you will find explained on our discussion boards or in a future article here), the chances that you will hit your goal are not good.

As you forecast increased sales, you must study the underlying metrics. In automotive recycling, if you forecast a 5% increase in parts sales, which seems achievable, how will your metrics measuring buying, processing, and deliveries/fulfillment be affected? Unless you are going to process the same number of cars, but raise the price per unit, you will need to buy more cars. Can you buy more? Ask the buyers. Can you process more? Ask the dismantlers. Do you have the racks to hold more parts? Or are you planning faster turns? Do you need to add another salesperson? Will there be more deliveries or shipping? All of these departments are likely to be affected, and unless you consider all of their metrics in the plan, and get everyone committed to pulling their oar, your plan is unlikely to succeed.

Bottom up budgeting is also a useful method for planning capital expenses like buying another dismantling lift, forklift, or even a new phone system to make your salespeople more efficient. Do your salespeople want the new system badly enough to commit to the 5% goal without another salesperson? A restaurant has to consider table turns, cost of food, and the size of their coolers before forecasting additional sales. Do they have adequate parking for the new customers? All businesses, from restaurants to electrical contractors, need bottom up budgeting.

Auto Manufacturers Step Up to Support RYR Recently, the Clean Air Foundation completed agreements with several auto manufacturers to provide discounts to Retire Your Ride participants towards the purchase of a new vehicle These include Chrysler Canada, Ford Canada, and to a certain extent Hyundai Canada. All of these incentives are a "top up" to the base \$300 cash a donor receives and they need to show proof of participation in RYR to receive the manufacturer incentives.

The addition of these new incentives does not change the manner in which the program is run. Recyclers will continue to be assigned vehicles through their provincial call centres; it is not the role of dealers or the public to change the process in order to speed up their ability to benefit from these great new rewards.

In other words. It is business as usual!

Members must also continue to exhibit caution and due diligence when donors arrange to drop their vehicles off at your facility - until the Call Centre approves the application and assigns the vehicle to you officially, it is not your vehicle and you are liable for the \$300 if the vehicle is ineligible. Please make sure you understand all of the program rules and policies before vehicles are dropped of

Overnight VW Canada announced a top up incentive of \$1000 on their 2009 Jetta for participants who can prove they have donated to RYR. At this time, this program is completely outside of the RYR program as we, and CAF, are just hearing the details.

#### **Retire Your Ride Milestones**

We set a one-day record vesterday for RYR donations - 185 in one day (Ontario only), which is a 30% improvement over the previous best. At some point this week, we will pass the 10.000 vehicle mark since the start of the program in March. And we have 103 recycler participants on the program - the most in Canada.

# Ontario Tire Stewardship Update

OARA participated in a Technical Committee meeting with OTS this week to provide input in to the implementation of the program. The biggest issues that came up were that non-program trices (ie, those tires in inventory before September 1st or before you registered for the program, whichever is earlier) are expensive to get rid of (up to \$3 per tire) as the Haulers are focussing on the subsidized tires; Northern Haulers aren't pleased with the compensation under the program so their could be capacity issues to move tires; and most importantly - tires collected after the program start date (September 1st) but BEFORE a Collector completes their registration for the program are not part of the program of free removal and the 88¢ Collector subsidy. I would urge all those Members who are going to register to do so immediately to save some money. The process isn't hard and is well documented at the OTS website - http:// www.ontariots.ca. If you have any questions about the program, please let us know - we may already have the answer or can ask on your behalf.

#### Solera Adds Salvage Auction Business

We have had good uptake from RYR participants regarding the new policies for the method of vehicle allocation (email or fax), and the vehicle drop off procedures. If you are not familiar with these options and requirements, please contact the OARA Office.

Volkswagen Supports RYR Volkswagen officially announced their participation in RYR on Friday, offering \$1,000 off of their 2009 Jetta - the Green Car of the Year. This won't provide a lot of extra volume, but will generate more press coverage, which will. Five manufacturers are officially on board - Hyundai, Chrysler, Ford, GM and now Volkswagen. Many are deploying extensive ad campaigns and point-of-sale promotions - driving significant volumes through the overall program.

# Mercury Switch Sweep Continues

Its not too late to participate in the second switch sweep of Clean Air Foundation's Switch Out program. Minister Makes Early Announcement Regarding Vehicle Stewardship The Minister of Environment, John Gerretson, made a speech to kick off Waste Diversion Week last week, at which he hinted at future Extended Producer Responsibility (EPR) for vehicles. The reception was sponsored by OARA, organized by the Recycling Council of Ontario, and attended by over 125 influential waste and stewardship stakeholders. The speech revolved around enhancements coming to the Waste Diversion Act (WDA) and Waste Diversion Ontario (WDO).

"Looking to the long-term, we will also propose a 5-year diversion plan that would include new material designations and progressive targets. We would be looking at requiring producers to divert a range of new materials, including, for example:

- blue-box type materials from the IC&I sector more electronic waste
- and, down the road, other materials like furniture, carpet, mattresses, vehicles, and construction and demolition waste."

Presently the WDO and its industry funding organizations Stewardship Ontario (blue box and municipal household and special waste), Ontario Tire Stewardship (scrap tires) and Ontario Electronics Stewardship (electronics), manage waste diversion in the province. The Minister announced that all future waste diversion initiatives will utilize the principles of EPR, bringing Ontario in line with much of the rest of the world. Ontario's recent forays into EPR have involved tires, electronics, and municipal hazardous and special waste (see below for the phase 2 items of interest)

The consultation document to update the WDA is being released by the Minister tomorrow morning and is expected to have 60 day comment period.

MHSW Phase 2 Program Approved The MOE has passed the Phase 2 of the Municipal Household and Special Waste (MHSW) program, and new designated substances will begin to be stewarded starting July 2010. Two items have been designated that are of interest to auto recyclers: 1) Mercury switches from automotive sources; and 2) non-lead acid motive batteries (ie hybrids).

For non-lead acid motive batteries, sufficient information is not available to designate OEMs as stewards; rather the WDO will be undertaking a research project to study how hybrid batteries are currently handled by industry

For the mercury switches, the OEMs have been designated as stewards and as such are responsible for ensuring recovery targets are met and they are financially responsible for meeting

those targets. If that sounds a bit like Switch Out - you are right, but the exception to the Ontario program is that a \$3 incentive is being proposed. The program would commence July 1 2010 (and like the tire program, no stockpiling will be allowed) and is remarkable short of details. But we are working with Stewardship Ontario, the WDO and the Clean Air Foundation to sort out the details

Management Article - Are Your Sharing Teeth in Your Operation? by Ron Sturgeon Three old men are at dinner. They have a splendid meal: steaks, baked potatoes, veggies. But they have a problem. They have only one set of teeth. It's going to take them a while to eat. I'll let you imagine whether they share a little at a time or one finishes before passing the teeth on. Gross, I know

Sharing teeth is not efficient. It creates a bottleneck at the dinner table. How many of your employees are sharing teeth? In the recycling industry, we tend to be cheap because we're bootstrappers. And many of us have had little training in decoding the financial and operating metrics that could show the costs of sharing teeth. Couple that with our aversion to debt, and it's easy to see why many of us have employees sharing teeth.

can this help you make more money

When I was an auto recycler, we shared teeth for a long time. For years, we had three dismantlers and one forklift. The dismantlers always wanted another forklift. They often waited for 30 minutes or more because the forklift was tied up unloading a transport truck or doing other duties. While they waited, they would divert their efforts to a lower productivity task or just take a break. They had asked for the forklift and I had dismissed their request as whining. Eventually, however, I listened, and I studied how long they waited to use the forklift. I asked them to tell me how many additional cars they could process per week with a second forklift. When I reconciled their numbers against how many minutes were lost per day per employee, buying another forklift was an easy decision. The forklift decision was good because we could dismantle the extra cars using our existing bays more efficiently since we could not add any more.

Doing this exercise with my employees and considering how a second forklift might alter the other metrics of my business is part of doing bottom up budgeting. I used the same method when we were struggling to hit sales targets. Using bottom up budgeting helped me see that sales growth required hitting delivery targets. Eventually, we realized we needed another truck. Later we improved per driver deliveries by changing compensation from hourly to pay per stop. After these changes, our dismantlers and drivers made more money, and we earned a higher return on assets.

Understanding metrics and changing my employee compensation plan helped my business grow at the expense of my local competitors. Where did I learn to use metrics and get the pay per stop idea? I belonged to a group of auto recyclers that met twice a year to compare metrics and discuss successful business growth techniques specific to our industry. One of the other members had much better metrics for per driver deliveries than the rest of us. He shared the idea with the group, and I made a lot of money applying it.

If your business could benefit from fresh ideas to lower costs, raise revenues, and increase profits, join an industry specific Peer Benchmarking Review Group. #### **ARC Wins RYR Audit Delivery Contract**

We are very pleased to announce that ARC has won the contract with Environment Canada to source, hire and train the auditors for the RYR program on a national basis, and to deliver the audits themselves on a regional basis. This is a big win for ARC to ensure the audits happen in a reasonable and sustainable fashion with the goal of building the industry up, not tearing it down.

# OARA Supports ARC Resolution on the Tacoma Program

The OARA Board at a recent conference call has pass a motion in support of the ARC resolution regarding the re-use of Tacomas acquired through the ARC Tacoma Recovery Program, which states: "That the members of ARC be obliged to sell only the parts of vehicles obtained through the Toyota Tacoma salvage program and any similar future program. It is strictly prohibited for an ARC members to sell or give these vehicles to anyone (member, consumer or entity), under penalty of immediate expulsion from their provincial association. Under the present or future salvage program with automobile manufacturers, it is strictly prohibited for ARC members to sell to the same customer a vehicle that is complete or cut into two sections, under penalty of immediate expulsion from their provincial association. It is also prohibited to sell a frame to anyone. Example: a complete front can be sold; a truck box can be sold; a cab can be sold. A cut front or a box and cab from the same truck cannot be sold to the same customer. Therefore, any vehicles obtained from these programs must be completely dismantled for resale of the recycled parts and/or pressed for scrap .

In summary, you risk your entire OARA Membership by not seeing these Tacomas as a source of parts. Period. While OARA has always had this policy of expulsion for

violation of this key point, the resolution is meant to remove any grey area. The Quebec and Atlantic associations have also passed the resolution.

We are also aware that several individuals are calling Members trying to buy Tacomas. Don't be tempted. ARC and Toyota continue to audit this program. Other opportunities with OEMs are out there - let's continue to show them that we are the industry to chose to responsibly handle all end-of-life vehicles

ARC won the 2008/2009 Affiliate Chapter of the Year award from the Automotive Recyclers Association.
 ARC is working on an agreement with OARA to adopt the Green Parts marketing program on a national basis.

 Retire Your Ride, the national vehicle recycling program exploded on to the scene and surpassed all expectations by the government, industry and participating Canadians. ARC wrote
the Code of Practice for auto recyclers to participate; implemented a recycler engagement strategy to obtain buy in from the industry; developed and deployed training for the Code in 15 cities for over 200 participants; is converting the in-person training to an online version; won the contract to hire and train auditors for the Code and coordinate at least 300 audits and inspections over the next two year; and overall, ARC acts as a consultant to Environment Canada, Summerhill Impact and its partners to ensure Retire Your Ride meets and exceeds its objectives. With one of the main objectives to raise awareness of modern auto recycling - Retire Your Ride has been a great vehicle to profi le our industry within government, the media and the motoring public. • ARC participated in four Advisory Committee meetings for the national Switch Out Program to recover convenience lighting switches from end-of-life vehicles. These meetings, hosted by

Summerhill Impact, bring ARC together with the Canadian Vehicle Manufacturer's Association (CVMA), the Canadian Steel Producers Association (CSPA), and the Canadian Association of Recycling Industries (CARI). ARC Members are consistently the top producers when it comes to removing mercury in this voluntary program - routinely accounting for over 80% of the switches even though we process less than 40% of the vehicles in Canada.

ARC hosted its first national meeting in Halifax Nova Scotia in conjunction with the Automotive Recyclers Association of Atlantic Canada (ARAAC).

• ARC continued to develop its manufacturer vehicle recovery programs, adding Kia Canada to the program it already operates with Toyota Canada. Two vehicle manufacturers have now contracted with ARC to manage vehicle recovery programs for them on a national basis, with ARC Members guaranteeing proper vehicle disposal and permanently retiring the vehicle and the VIN. We are in negotiations with a third OEM for another program.

Once again, ARC supported the Canadian Auto Recycler Magazine, providing editorial input and guidance, advertising recruitment, and our Directory of Members. This publication continues to be our best resources for displaying and explaining our industry to a growing international readership.
 ARC participated in an Ozone Depleting Substances consultation with Environment Canada, bringing Extended Producer Responsibility principles on a national basis to an automotive

byproduct. I have been invited to Basel Switzerland in March to provide an overview of the Canadian auto recycling sector at the International Auto Recycling Congress.

• In September 2010, ARC will host the International Roundtable on Auto Recycling (IRT) in Québec City. We are expecting approximately 200 delegates representing 15 countries. The IRT runs every 18-24 months in conjunction with the Automotive Recyclers Association (ARA), the European Group of Auto Recycling Associations (EGARA), the Japanese Auto Recyclers Association (JARA), the Malaysian Auto Recyclers Association (MARA), and the Auto Parts Recyclers Association of Australia (APRAA). The event will feature facility tours, presentations,

roundtable discussions, and will highlight the Canadian auto recycling scene on a global scale

### New Refrigerant to be Used in Vehicle A/C Systems

New Herrigerant to be Used in vence A/C Systems The U.S. EPA has proposed a rule for HFO-1234yf that would designate 1234yf as a substitute for CFC-12 and R-134a in mobile air-conditioning systems. Currently, the refrigerant of choice is R-134a, which has a global warming potential (GWP) of 1,430, while the 1234yf carries a GWP of 4. Japan is the first country to approve the new refrigerant for use in vehicle A/C systems. Toyota and Nissan will use it in new platforms going forward, particularly in the European Union, which requires new platforms introduced in member countries after January 2011 to use low global warming refrigerants. Beginning in 2011, the the European Union's (EU) Mobile Air-Conditioning (A/C) Directive requires refrigerants to have a GWP below 150. According to Society of Automotive Engineers (SAE) two-year CRP1234 study, HFO-1234yf can be safely accommodated through established industry standards and practices for vehicle design, engineering and manufacturing and service.
